The editor interviewed a kind and resourceful lady by the name of **Chris Urbanek**

Bridge:

- Chris went to Kenmore East HS Adult Education to take a tax course. There

were not enough people for the class so it was cancelled. Looking at a course schedule, she noticed a beginning bridge class (taught by Rhoda Jacobs) and decided to try it. She remembered thinking "You mean I have to STUDY!!??"

- Since only one of her friends played bridge, she found the Barrett Club right down the street where she lived. She started there on Thursday night novice group with her friend **Margaret Allen**; the director was **June O'Connor**.
- Her very first duplicate hand was played against **Joan Rose** and **Sue Neubecker**.
- Chris also took classes from **Alan Greer** and **Jeanette Michienzie**. **Dan Gerstman** also gave a series of classes that were excellent.
- She believes that newer players should have only one or two "experts" to answer bridge questions. **Dan Gerstman** is always a great source of bridge information, because of his credentials and experience.
- As a bridge Director Chris contacted **Peter Mollemet** on many occasions for advice regarding rulings.
- Her comments on the bridge community and Unit 116, Chris feels that it is full of wonderful and caring people. She experienced this firsthand while going through her health problems. She enjoys attending unit games, sectionals and regionals and appreciates all the work that volunteers put into running these events. It is not only the wonderful game of bridge itself that is so appealing but the people that play the game.
- One of her memorable moments in bridge was a few years ago going to the Ft. Lauderdale regional with **Joan Rose**, **Meg Klamp**, **Marcia Freed**, and **Jill Wooldridge**, playing in a KO. They were in a 3-way robin the 1<sup>st</sup> round with two teams surviving. One of the teams had at least one pro – a world champion. They were in the 2<sup>nd</sup> bracket, not the top one and she wondered what that person was

doing there. They lost both matches but stayed in the event because the team with the pro was disqualified for misrepresenting Masterpoints. The second round was another 3-way. They lost one match and won the other by only 1MP. They were now in the semi-finals (and guaranteed about 14 master points) after losing 3 matches and winning 1 by 1 IMP! She was sure the teams they met in the semi-final and final thought they would have an easy time with them – they didn't – Chris's team won.

- Chris taught a few classes for **Jeanette Michienzie**'s clubs in the 80's along with the free lessons that were always offered before her Thursday night's games. She recently began offering classes and enjoys it because of the students. It is a good feeling when a student does something at the table that they learned in class and it works well for them.

#### Personal

- Chris has been married for 32 years to Jerry, has no children, just cats. When she started playing duplicate 30 years ago, Jerry said, "Play as much as you want, just don't make me do it!" He did accompany her to many National Tournaments.
- Chris worked as a Forensic Chemist at the Erie County Central Police Services Forensic Lab. She is currently working part time at the same job. She was the first female technologist hired at the crime lab (in 1986) Atta way Chris!

After asking **Pat** and **Mike Weber** for an interview. your editor received the following:

Mike was a veteran of the Korean War. He learned to play bridge during basic training in the Army. He and his wife, Pat played social bridge for many years. We were pleasantly surprised when Pat became a life master in 2004 at a Niagara Falls Ontario game and Mike in the spring of 2005 at a Sectional game.

Mike is a graduate of Canisius High School and Erie Community College. It was his time spent with the Jesuits at Canisius that Mike credits as the foundation of his lifelong success and now takes great delight in having two of his grandsons attending his alma mater. He worked for Buffalo Gravel Corporation for sixteen years, ending his career there as Quality Control Manager. Mike took advantage of an opportunity to join W.R. Grace in sales. He retired as District Manager in the Sales Engineering Group in which Mike helped pioneer. **The Bridge "Gene-ie"  
By Eugene Harvey**

Hi everyone! The Gene-ie is back! ☺ Sorry for the lapse in columns...but I've successfully finished my degree in library science, and the career change is over. Now it's back to BRIDGE! ☺ \*grin\*

*Hi Eugene! I've missed you... Here are our hands for bidding:*

North (partner)	♠ K Q J T x x
	♥ x
	♦ K Q J T x x
	♣ x
South (me)	♠ x x
	♥ A x
	♦ A x x x x

♣ x x x x

*Here is the bidding:*

W	N	E	S
1♥	X(!)	2♥	P (!!)
P	4♠ (!!!)	5♥	P??

*...by this time, I was totally confused! Here are my questions:*

*(!) Which is better over 1♥: a X, or a Michael's cuebid?*

What your partner was trying to do was double and then bid their own suit. The problem is they are TWO-suited. Most times when I have chance to describe two "things" in one bid, I do so. Thus, I would have opted for the Michael's cuebid (2♥) to show ♠s plus a minor suit (♣s or ♦s). Most players I know use Michael's when they have a "mini" (less than opening values) or a "maxi" (more than opening values) hand; with only 4 losers, this would be a "maxi" hand. (With the equivalent of an opening hand, you simply would plan to bid your suits normally.)

*(!!) Can I bid over 2♥ with my hand?*

Absolutely! You must interpret your partner's X as a basic takeout double (initially), even though they do not have that kind of hand. In your mind, you should picture shortness in ♥s with support for the unbid suits, which would include ♦s. With 11 total support points (8 HCP + 2 for doubletons + 1 extra trump), you need to make a free bid (3♦) to show values and the ♦ fit. If you pass, partner can never expect the hand you have. Bid now while you have the chance, or you might (will!) get shut out!

*(!!!) by this time, I was totally confused, but I must bid 5♠ because I have two A's, right?*

Although this bidding should not exist, it doesn't mean that it doesn't happen at the bridge table. ☺ If I were to interpret your partner's X and jump to 4♠, I would assume they have a very long, strong spade suit and a distributional hand equivalent to a 2♣ opener. After 5♥, with 2 spades and 2 aces, I might have pushed to 6♠!! However, that contract would have failed because partner does not have the hand they said they had.

Tsk, tsk. Certainly, though, you need to bid 5♠ based on partner's strength-showing bids.

Here's a quick summary of some principles:

- Doubling and bidding your own suit likely shows a strong, single-suited hand. Doubling and then JUMP-bidding your own suit shows even more strength, likely a 2♣ opener with distribution.
- As responder, bid NOW when you have a fit and the points to bid at the appropriate level. You may not have another opportunity to bid, and partner will never know about your hand.
- Take some time to learn doubles and how to handle distributional hands. You will improve your bidding dramatically!!

**“A Passion and Addiction For 3-  
NoTrump”  
By Lou T. DiLorenzo**

Over the years, I have frequently asked bridge players which contract they thought was the most successful. Without exception, the response has been 3-no trump and continues to be. This comes as no surprise as four of my prior studies revealed. Three-no trump contracts triumphed 77% of the time, roughly three out of every four times they were bid. Contracts in the majors were made only two out of every three bids. What has surprised and baffled me is why players bidding begin by pursuing a major contract and relegating a 3-no trump contract as secondary or by default.

Other findings in the studies further account for why players have “felt” 3-no trump to be the best contract. When the 3-no trump contracts were made, two out of every three times, overtricks were achieved. Further findings showed when the same hands were played in both 4-Hearts or 4-Spades and 3-no trump contracts, the latter resulted in higher scores 5 to 42% of the times when the major contracts held the “sacred” eight trump count.

Bridge players are often conservative as the studies showed in 233 partial contracts, They were all one bid short of game at either 3-Hearts, 3-Spades or 2-No trump. However when played 3-Hearts made game 34% of the time, 3-Spades made game 36% of the times and 2-no Trump made game 56% of the time. Is it any wonder Truscott writes in *Bridge Book* that Sidney Lenz “...had a passion and addiction for no-trump.”

Alas, 3-no trump does go down 25% of the time and the studies shed some light on when this does occur as follows:

1. A void in either partner's hand
2. Two singletons in either or both hands combined.
3. Two doubletons in either or both hands combined.
4. Qxx as the only stopper in the combined hands.
5. Less than 22 HCP's.

These five holdings account for over two-thirds of the 3-no trump contracts. These

hands should not have been in 3-no trump contracts.

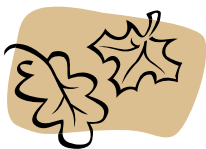
Can we have it both ways? I think so. Bidding can begin by looking for a 3-no trump contract. By bidding “stoppers up the line”, (SUTL), it can be determined whether a 3-no trump contract exists – **AT THE ONE LEVEL** (providing oppo-nents don’t interfere). If 3-no trump isn’t there, bidding for a fit in a major can begin at the two level.

SUTL will be described in the next issue of the Bridge Buff.
